Description of necessary first aid measures

Eye contact

: Immediately flush eyes with plenty of water, occasionally lifting the upper and lower eyelids. Check for and remove any contact lenses. Continue to rinse for at least 10 minutes. Get medical attention if irritation occurs.

: Remove victim to fresh air and keep at rest in a position comfortable for breathing. : To the Doctor: This product contains mineral oil. Accidental injection with this oil-based product, even in small quantities, can cause intense swelling which may, for example, result in ischaemic necrosis and the loss of a digit. Expert PROMPT, surgical attention is required and may necessitate early incision and irrigation of the injected area, especially where there is involvement of finger pulp or tendon.

Specific treatments

In case of accidental self-injection of oil emulsion vaccines, get medical attention immediately.

SEEK IMMEDIATE MEDICAL TREATMENT at nearest Hospital Emergency Room even if only a very small amount is injected, as failure to treat may result in the mineral oil adjuvant causing sterile abscess and/or loss of affected finger or thumb.
